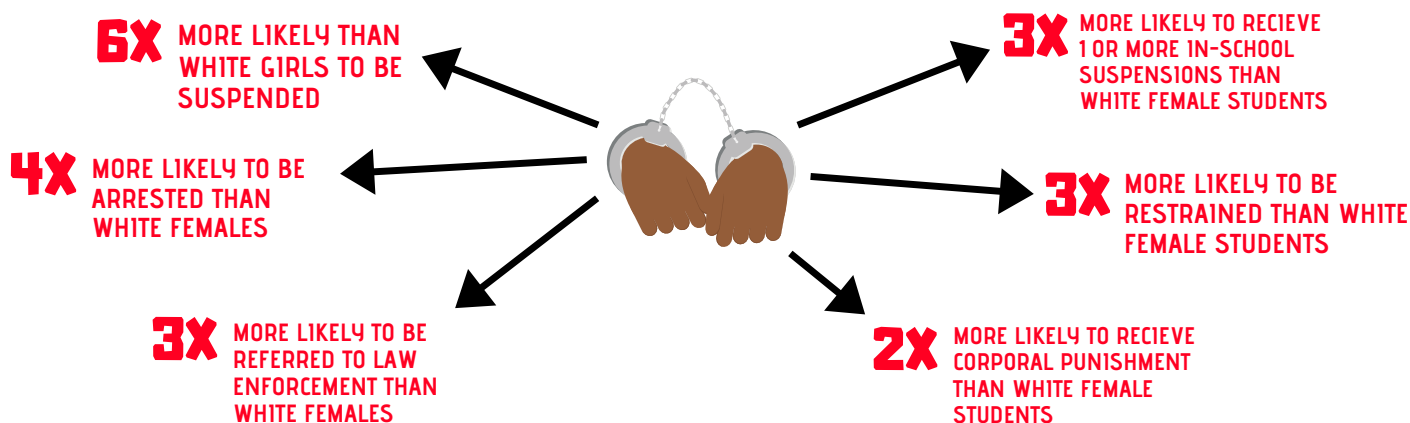
WHAT IS THE SCHOOL TO PRISON PIPELINE?

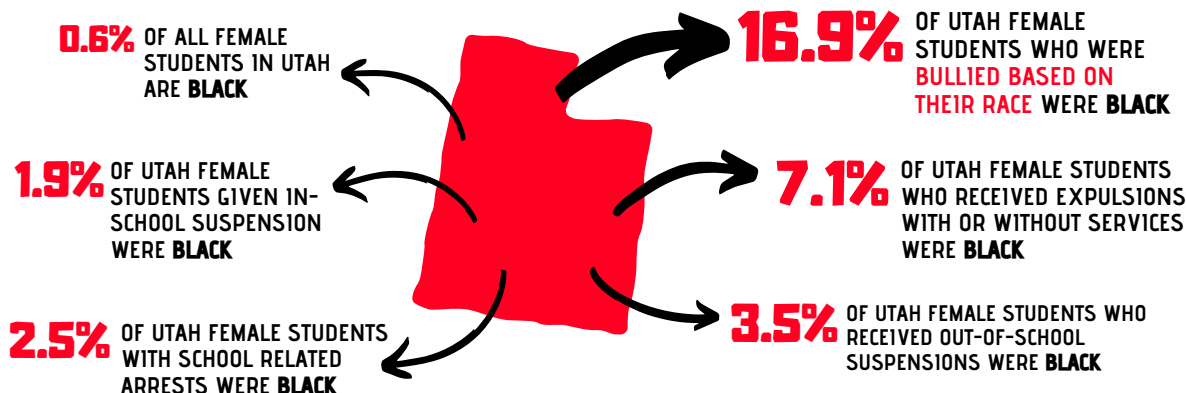
