Welcome – Byron Russell, Co-Chair

Byron Russell welcomed attendees to the meeting.

Racial Equity Work – Byron Russell

- Multicultural and MLK commissions survey sent out to the community.
- Kellogg Foundation will be joining in a partnership, to contribute to long term approaches in addressing racial equity.

Transportation Partnership with Wasatch Front Regional Council - Andrew Gruber

- Noted the disproportional health and equity issues within communities, and the importance with transportation and access.
- Work in collaboration with the subcommittee to make sure transportation access is available and safe for all
 communities.

Leavitt Partners Research Around Social Determinant of Health within Minority Communities - Brooke Zollinger

- Leavitt partnership will be researching intersections between racial climate and Black Lives Matter. Exploring evidence linking primary domains of racism (structural, cultural, and individual-level discrimination) to mental and physical health outcomes to drive research and policy.
- Partnership can help elevate the conversation in Utah, with data and drive policies surrounding health equity.
 - This partnership will continue to develop and be explored.

Social Services – Asha Parekh

- Current Focus Areas: Rental Assistance and Eviction, Mental Health and Crisis Counselors, and Unrestricted Resources.
- Rental Assistance:
 - Application has been simplified.
 - On July 25th funding will be available to those receiving unemployment insurance payments who previously were ineligible.
 - o Applicants must show a loss of 20% of their income in the last 30 days.
 - o Additional County funding is available.
 - Rental assistance can extend up to six months.
- Eviction Data Project: Six points of interest
 - Comparison
 - Assigned Counsel
 - o Judgements
 - Language
 - Treble Damages
 - Hearings
- Mental Health Funding:
 - Funding has gone to support 50 crisis counselors due to COVID-19.
 - Language support provided in addition to English.
- Unrestricted Resources:

- Outreach to United Way of Salt Lake to increase services to affected communities.
- Exploring more resource opportunities and the education fund.

Communications – Juan Becerra

- PSA's are very responsive and available.
- Next step is placing key individuals with the media to continue to spread information on resources.
- Myth Vs. Truth project to inform communities and bring light to misconceptions.

Health Equity - Dulce Díez

- Hiring program to provide positions among communities members.
- Funding is being given to local health care centers with community health workers.
- Over 100 positions open to minority communities to bring funding back within those communities.

Digital Equity – Jenny Hor

- Recognized the disconnect between health needs and digital equity, and partnerships are being established to build upon that.
- Comcast has been aware of the lack of internet access that rural Utah schools experience.

Comunidades Unidas — Mayra Cedano

- Community members are experiencing debt for COVID-19 medical expenses.
- Comunidades Unidas is creating a family emergency fund with unrestricted funding for families. Those who are interested in getting involved can contact Mayra Cedano.
